**WHEREAS**, in view of the foregoing, the SP Committee on Finance, finding the documents to be in order, deemed it best to approve the same;


**NOW THEREFORE**, on motion of Hon. Laurence Marxlen J. de la Cruz, unanimously seconded by all members present;
