RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2025 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION PESOS (\$\mathbb{P}2,000,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 Supplemental Budget No. 3 of the Municipality of San Enrique, Negros Occidental, with a total appropriation of Two Million Pesos (₱2,000,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 03, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;
