## RESOLUTION NO. 1224 Series of 2025

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-02 OF THE CITY OF CADIZ, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID CITY IN THE AMOUNT OF TWENTY ONE MILLION ONE HUNDRED TWELVE THOUSAND TWO HUNDRED PESOS (P21,112,200.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2025-02 of the City of Cadiz, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said city in the total amount of Twenty One Million One Hundred Twelve Thousand Two Hundred Pesos (P21,112,200.00) that was submitted to the Sangguniang Panlalawigan for review on October 14, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, CY 2016 Updated Budget Operations Manual for Local Government Units, implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-02 of the City of Cadiz, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said city in the total amount of Twenty One Million One Hundred Twelve Thousand Two Hundred Pesos (P21,112,200.00) subject to the posting requirements under Section 59 of the Local Government Code of 1991 and the following conditions:

- 1. The purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023, if the Department of Budget and Management (DBM);
- 2. The Local Chief Executive (LCE), upon approving the AO, shall sign in very page thereof pursuant to Section 54 (a) of the LGC, which provides that, "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof
- 3. Strict adherence in the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan: (a) Within three days after approval, the secretary to the Sanggunian Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils"

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.
