RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-003 OF THE CITY OF KABANKALAN, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2025 FROM GOVERNMENT EQUITY (2024 SURPLUS) UNAPPROPRIATED BALANCE PER APPROPRIATION ORDINANCE NO. 2025-002 IN THE AMOUNT OF NINE MILLION EIGHT HUNDRED EIGHTY-TWO THOUSAND SEVEN HUNDRED FORTY-FOUR AND 74/100 PESOS (9,882,744.74) AND FOR THE CREATION AND FUNDING OF THE FOLLOWING POSITIONS UNDER THE AFORESAID SUPPLEMENTAL BUDGET"

WHEREAS, thereby presented to the Sangguniang Panlalawigan for appropriate action is Appropriation Ordinance No. 2025-003 of the City of Kabankalan, Negros Occidental entitled: "AN ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2025 FROM GOVERNMENT EQUITY (2024 SURPLUS) UNAPPROPRIATED BALANCE PER APPROPRIATION ORDINANCE NO. 2025-002 IN THE AMOUNT OF NINE MILLION EIGHT HUNDRED EIGHTY-TWO THOUSAND SEVEN HUNDRED FORTY-FOUR AND 74/100 PESOS (9,882,744.74) AND FOR THE CREATION AND FUNDING OF THE FOLLOWING POSITIONS UNDER THE AFORESAID SUPPLEMENTAL BUDGET";

WHEREAS, said Appropriation Ordinance is recommended for approval and declared operative in its entirety effective October 7,2025 subject to the posting requirements under Section 59 of the LGC of 1991 and subject further to the following conditions and reminder:

- 1. The Human Resource, Position Classification and Staffing Actions, and Creation of Positions shall be consistent with the rules and regulations established under Civil Service Commission Memorandum Circular No. 12, s. 2022; CSC Memorandum Circular NO. 12, s. 2017, as amended by CSC MC No. 14, s. 2018, Local Budget Circular No. 53; Budget Circular NO. 2019-1; and other existing guidelines and policies. Position Titles and Salary Grades shall conform to Local Budget Circular No. 137 dated July 13, 2021 of the Department of Budget and Management. Moreover, creation of positions shall be strictly subject to Section 329(g) of RA 7160, which states that: "The creation of new positions and salary increases or adjustments shall in no case be made retroactive." It is further subject to the condition, among others, that the Salary Standardization Law has been fully implemented";
- 2. The purchase ad specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018, Budge Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023, of the DBM;
- 3. The appropriation for wages Casual/Contractual shall be subject to pertinent budgeting, accounting, and auditing rules and regulations, and to the following provisions of CSC's 2017 Omnibus Rules on Appointments and Other Human Resource Actions, as follows: (1) Employees under contractual or casual appointment are entitled to the same benefits enjoyed by regular employees, and (2) in no case shall a casual employee perform the duties and responsibilities of the vacant plantilla and Management;
- 4. The payment of Personnel Economic Relief Allowance shall be pursuant to Budget Circular Nos. 2009-3 dated August 18, 2009, and September 2011-2 dated September 26, 2011 of Budget and Management;
- 5. The utilization and disbursement of appropriations for Confidential Expenses shall be subject to the provisions of the Guidelines on the Entitlement, Release, Use, Reporting and Audit of Confidential and/or Intelligence funds per Joint Circular 2015-01 dated January 8, 2015 of the COA, DBM, DILG, GC for GOCCs and DND and it should not exceed thirty percent (30%) of the total annual amount allocated for Peace and Order Program (POP) of the LGU as approved by the Peace and Order Council;
