RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-03 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF SEVEN MILLION NINE HUNDRED THOUSAND PESOS (P7,900,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 General Fund Supplemental Budget No. 3 of the Municipality of Hinoba-an, Negros Occidental, with a total appropriation of Seven Million Nine Hundred Thousand Pesos (P7,900,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-03;
