RESOLUTION APPROVING RESOLUTION NO. 2025-189 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, APPROVING CDC RESOLUTION NO. 204, SERIES OF 2025, THEREBY APPROVING THE 20% ANNUAL DEVELOPMENT PLAN FOR CY 2026 OF THE SAID CITY IN THE AMOUNT OF TWO HUNDRED TWENTY SIX MILLION NINETY FOUR THOUSAND THREE HUNDRED NINETY THREE PESOS (P226,094,393.00)

WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 2025-189 of the City of Talisay, approving CDC Resolution No. 204, Series of 2025, thereby approving the 20% Annual Development Plan for CY 2026 of the City of Talisay, Negros Occidental in the amount of Two Hundred Twenty Six Million Ninety Four Thousand Three Hundred Ninety Three Pesos (P226,094,393.00);

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in accord with the provisions under Republic Act No. 7160, mandating Local Government Units to formulate their local development plans/programs/projects/activities based on their respective thrusts/priorities;
