RESOLUTION APPROVING RESOLUTION NO. 2025-279 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL, APPROVING THE 2026 INTEGRATED ANNUAL INVESTMENT PROGRAM-ANNUAL DEVELOPMENT PLAN (AIP-ADP) OF THE CITY OF VICTORIAS TO BE FUNDED FROM THE 20% DEVELOPMENT FUND (CY 2026) IN THE AMOUNT OF ONE HUNDRED NINETY ONE MILLION SIX HUNDRED THOUSAND PESOS (₱191,600,000.00)

WHEREAS, thereby presented for review and appropriate action of Sangguniang Panlalawigan of Negros Occidental is Resolution No. 2025-279 of the City of Victorias, Negros Occidental, entitled: "APPROVING THE 2026 INTEGRATED ANNUAL INVESTMENT PROGRAM-ANNUAL DEVELOPMENT PLAN (AIP-ADP) OF THE CITY OF VICTORIAS TO BE FUNDED FROM THE 20% DEVELOPMENT FUND (CY 2026) IN THE AMOUNT OF ONE HUNDRED NINETY ONE MILLION SIX HUNDRED THOUSAND PESOS (₱191,600,000.00)";
