**RESOLUTION APPROVING CITY ORDINANCE NO. 05, SERIES OF 2025 OF THE
MUNICIPALITY OF VALLADOLID SUPPORTING THE IMPLEMENTATION OF THE
NATIONAL IMMUNIZATION PROGRAM (NIP) OF THE DOH IN THE LOCAL
GOVERNMENT OF VALLADOLID, NEGROS OCCIDENTAL AND PROVIDING
FUNDS THEREOF**

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 05, series of 2025 of the Municipality of Valladolid supporting the implementation of the National Immunization Program (NIP) of the DOH in the local government of Valladolid, Negros Occidental was submitted for review by the Municipality of Valladolid to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, in the pursuit of the Constitutional provision that mandates that the State shall protect and promote the right to health of the people and instill health consciousness among them, the Municipality of Valladolid has embodied this policy through the enactment of the above-mentioned ordinance;

WHEREAS, the subject ordinance primarily finds legal grounding from the Local Government Code, specifically, under Section 16 of the Code which provides that:

"Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, in view of the foregoing, the SP Committee on Health, recommends approval of the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, and duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 05, series of 2025 of the Municipality of Valladolid supporting the implementation of the National Immunization Program (NIP) of the DOH in the local government of Valladolid, Negros Occidental.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
