RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY THE OFFICE OF THE PRESIDENT (OP) IN FAVOR OF THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE OFFICE OF THE PRESIDENT IN SUPPORT TO THE PROVINCE'S RECOVERY AND REHABILITATION EFFORTS DUE TO THE EFFECTS OF TYPHOON TINO IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00)

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Deed of Donation to be executed by the Office of the President (OP) in favor of the Provincial Government of Negros Occidental relative to the financial assistance that will be extended by the Office of the President in support to the province's recovery and rehabilitation efforts due to the effects of Typhoon Tino in the amount of Fifty Million Pesos (P50,000,000.00);

WHEREAS, under said Deed of Donation, the Office of the President shall donate to the province the total amount of Fifty Million Pesos (P50,000,000.00) from the Socio-Civic Projects Fund (SCPF) and shall be used as cash assistance to affected families and provision of food meals, medicines and other medical supplies, and non-food items;

WHEREAS, said Deed of Donation is consistent with the provision as stated in Sections 25(c), 17(f) and 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Disaster Preparedness, finding the subject contract to be favorable and all the necessary documents to be in order, deemed it best to approve the same;

NOW, THEREFORE, on motion of Hon. Richard Julius L. Sablan and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Governor to sign, for and in behalf of the Province, the Deed of Donation to be executed by the Office of the President (OP) in favor of the Provincial Government of Negros Occidental relative to the financial assistance that will be extended by the Office of the President in support to the province's recovery and rehabilitation efforts due to the effects of Typhoon Tino in the amount of Fifty Million Pesos (P50,000,000.00).

RESOLVED FURTHER, to grant authority to the Provincial Treasurer to release the fund in accordance therewith.
