RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2025 OF THE MUNICIPALITY OF HINIGARAN, NEGROS OCCIDENTAL COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 02 OF THE SAID MUNICIPALITY IN THE AMOUNT OF FIVE MILLION PESOS (\$\mathbb{P}\$5,000,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 General Fund Supplemental Budget No. 02 of the Municipality of Hinigaran, Negros Occidental, with a total appropriation of Five Million Pesos (₱5,000,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 02, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Laurence Marxlen J. de la Cruz, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety effective October 9, 2025, the Appropriation Ordinance No. 02, Series of 2025 of the Municipality of Hinigaran, Negros Occidental covering the FY 2025 General Fund Supplemental Budget No. 02 of the said municipality amounting to

Five Million Pesos (₱5,000,000.00), subject to the posting requirements under Section 59 of the Local Government Code, and further subject to the following conditions and reminders:

- 1. The utilization of the 20% Development Fund shall be in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020 and consistent with the approved Annual Investment Program (AIP).
- 2. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the Implementing Rules and Regulations of R.A. 10121, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013.
- 3. That Section 56 in relation to Section 326 and 327 of the Local Government Code provides that within three (3) days after approval of the Ordinance authorizing the annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

RESOLVED FURTHERMORE, that compliance with the existing laws, rules, and regulations shall be the responsibility of the municipality;

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
