RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-01 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 OF THE SAID MUNICIPALITY IN THE AMOUNT OF NINE MILLION FIVE HUNDRED THIRTY NINE THOUSAND SIX HUNDRED FORTY PESOS AND FIFTY SIX CENTAVOS (P9,539,640.56)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2025-01 of the Municipality of La Castellana, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 1 of the said municipality in the total amount of Nine Million Five Hundred Thirty Nine Thousand Six Hundred Forty Pesos and Fifty Six Centavos (P9,539,640.56) that was submitted to the Sangguniang Panlalawigan for review on September 24, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;
