RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 003, SERIES OF 2025 OF THE MUNICIPALITY OF PONTEVEDRA GRANTING A YEARLY CASH SUBSIDY AND ADDITIONAL BENEFITS TO SOLO PARENTS OF THE MUNICIPALITY OF PONTEVEDRA

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 003, series of 2025 of the Municipality of Pontevedra granting a yearly cash subsidy and additional benefits to solo parents of the Municipality of Pontevedra;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Pontevedra to enact and the same is enacted to localize and operationalize the benefits mandated under R.A. 11861, otherwise known as the Expanded Solo Parents Welfare Act;

WHEREAS, subject ordinance is consistent with R.A. 11861, otherwise known as the Expanded Solo Parents Welfare Act, however the municipality is reminded that the corresponding appropriations are duly enacted and all auditing, accounting and budgetary requirements are strictly followed;
