RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF KABUTOY FISHERFOLK ASSOCIATION (KABUFA) IN THE PROVINCE OF NEGROS OCCIDENTAL

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 23, 2025, the Department of the Interior and Local Government issued Memorandum Circular No. 2025-060, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the Kabutoy Fisherfolk Association (KABUFA) with office address at Purok Caimito Barangay San Juan, Sipaway Island, San Carlos City, Negros Occidental through its President, Ms. April Honey G. Arado, has signified its intention to be an accredited CSO in the Province of Negros Occidental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the Kabutoy Fisherfolk Association (KABUFA) has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2025-060;
