RESOLUTION APPROVING CITY ORDINANCE NO. 2025-018 OF THE CITY OF SIPALAY, NEGROS OCCIDENTAL, AUTHORIZING THE PROPOSED BORROWING OF THE CITY GOVERNMENT OF SIPALAY, NEGROS OCCIDENTAL IN THE AMOUNT OF FOUR HUNDRED SEVENTY EIGHT MILLION FIFTY THOUSAND PESOS (P478,050,000.00) FROM LAND BANK OF THE PHILIPPINES TO FINANCE THE VARIOUS PRIORITY PROJECTS OF THE CITY

WHEREAS, thereby presented to the Board for review and appropriate action is City Ordinance No. 2025-018 of the City of Sipalay, Negros Occidental, authorizing the proposed borrowing of the City Government of Sipalay, Negros Occidental in the amount of Four Hundred Seventy Eight Million Fifty Thousand Pesos (P478,050,000.00) from Land Bank of the Philippines to finance the various priority projects of the city:

- A. P125,000,000.00 Term Loan 12 to finance the acquisition of the following lands:
 - a. P71,000,000.00 for 20 hectares New Public Cemetery and for other purposes;
 - b. P9,000,000.00 for 1.5 hectares for New Barangay Site, Brgy. Maricalum;
 - c. P45,000,000.00 for 3 hectares for New Public Market at Brgy. Gil Montilla.
- B. P120,050,000.00 Term Loan 13 to finance the acquisition of various brand-new equipment and acquisition of the following:
 - a. P62,050,000.00 for the acquisition of various brand-new equipment
 - i. Two (2) Units Garbage Compactor;
 - ii. One (1) Unit Suction Truck (6 Cubic);
 - iii. One (1) Unit Suction Truck (8 Cubic);
 - iv. Three (3) Units Dropside Truck;

- v. One (1) Unit Wheeled Excavator;
- vi. One (1) Unit customized rescue truck.
- P8,000,000.00 for the acquisition and installation of 100KW Solar Panel for the New Government Center;
- P42,000,000.00 for the acquisition and installation of Close-Circuit Television (CCTV)
- d. P8,000,000.00 for the acquisition and installation of a brand-new elevator unit (9-passenger capacity)
- C. P233,000,000.00 Term Loan 14 to finance the construction of the following projects:
 - a. P180,000,000.00 for Site Development of 12 hectares relocation site in Sitio Bunga-bunga, Brgy. Canturay:
 - Earthworks road works, sidewalks, curbs and gutter (for completion);
 - ii. Drainage system (for completion);
 - iii. Water system (with drilling and 1000-liter elevated tank);
 - iv. Partial Power Supply;
 - Perimeter fence, slope protection and retaining wall.
 - P8,000,000.00 for the construction of a Water Filtration Facility at the New Government Center, Brgy. Gil Montilla;
 - P45,000,000.00 for the construction of Water Supply System (Level II) in six barangays (Camindangan, Manlucahoc, Cabadiangan, Nabulao, Maricalum, and Cayhagan)

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the said ordinance reveals that the same is in accord with the provisions as stated in Sections 297, 298 and 299 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same, provided, that the service ceiling and net borrowing capacity certifications issued by the Bureau of Local Government Finance (BLGF) of the Department of Finance shall be complied with, to ensure that the City of Sipalay's indebtedness does not exceed twenty percent (20%) of its regular income, consistent with principles of fiscal accountability and sustainability;

NOW, THEREFORE, on motion of Hon. Laurence Marxlen J. de la Cruz and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 2025-18 of the City of Sipalay, Negros Occidental.
