RESOLUTION APPROVING ORDINANCE NO. 10, SERIES OF 2025 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL, AMENDING SECTION 3 (3.1) OF ORDINANCE NO. 7, SERIES OF 2025, OTHERWISE KNOWN AS "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL IN THE AMOUNT OF FIFTY FIVE MILLION PESOS (P55,000,000.00) TO FUND THE CONSTRUCTION OF LEVEL 111 MUNICIPAL WATER SYSTEM (DESIGN AND BUILD)", ADDING SECTIONS 5, 6 AND 7 THERETO AND RENUMBERING THE PROVISIONS THEREOF

WHEREAS, thereby presented to the Board for review and appropriate action is the Ordinance No. 10, Series of 2025 of the Municipality of E.B. Magalona, Negros Occidental, amending Section 3 (3.1) of Ordinance No. 7, Series of 2025, otherwise known as "An Ordinance authorizing the proposed borrowing of the Municipality of E.B. Magalona, Negros Occidental in the amount of Fifty Five Million Pesos (P55,000,000.00) to fund the Construction of Level 111 Municipal Water System (Design and Build)", adding Sections 5, 6 and 7 thereto and renumbering the provisions thereof;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;
