WHEREAS, thereby presented for review and appropriate action of Sangguniang Panlalawigan of Negros Occidental is Resolution No. 2025-336 of the City of Bago, Negros Occidental, entitled: "RESOLUTION APPROVING RESOLUTION NO. 2025-11 OF THE CITY DEVELOPMENT COUNCIL-BAGO CITY, ENTITLED: "RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 7 FOR CY 2025 IN THE AMOUNT OF FORTY THREE MILLION NINE HUNDRED FORTY SIX THOUSAND SIX HUNDRED THIRTY EIGHT AND 48/100 PESOS (P43,946,638.48)
