RESOLUTION NO. 1301 Series of 2025

RESOLUTION RETURNING BACK RESOLUTION NO. 2025-395 OF THE CITY OF VICTORIAS OTHERWISE KNOWN AS 'RESOLUTION NO. 395 OF THE CITY OF VICTORIAS APPROVING THE VICTORIAS CITY LOCAL ENERGY EFFICIENCY AND CONSERVATION PLAN (LEECP) FOR THE PERIOD 2025–2030, AND INSTEAD ENACT AN ORDINANCE APPROVING THE SAME WITHOUT PREJUDICE TO SUBMISSION FOR REVIEW UNDER SECTION 56 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, the City of Victorias has embarked on a very loadable agenda in its energy program containing forty-two (42) pages Local Energy Efficiency and Conservation Plan for the period of 2025-2030;

WHEREAS, the same program is in consonance with other related energy plans of the national government such as the 9513, the Renewable Energy Act of 2008, as well as the Energy Conservation and Efficiency Act, otherwise known as "Implementing Rules and Regulations of Republic Act No. 11285 (Energy Efficiency and Conservation Act)" and as well the Electric Power Industry Reform Act (EPIRA LAW) or the RA 1936 and other pertinent rules, regulations and other adjunctive law that may be contributing to the overall plan to make the entire nation to eventually independent from non-renewable &, independent from importation or oil from foreign source;

WHEREAS, it is the modern practice that any long-lasting program carried by a local government must be through enactment of an Ordinance rather than passage of a Resolution for which the latter has its no effect on the former because it is inherently inferior from the order of hierarchy, as a Resolution cannot rise higher than the Ordinance;
