RESOLUTION APPROVING CITY ORDINANCE NO. 769, SERIES OF 2025 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL CREATING AND INSTITUTIONALIZING THE HUMAN RESOURCE MANAGEMENT OFFICE OF THE CITY GOVERNMENT OF TALISAY, NEGROS OCCIDENTAL

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 769, series of 2025 of the City of Talisay, Negros Occidental, creating and institutionalizing the Human Resource Management Office of the City of Talisay, Negros Occidental was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, the enactment of the subject ordinance finds legal basis from the 1987 Constitution of the Philippines, specifically in mandating the Civil Service Commission (CSC) as the central personnel agency of the government to establish a career service and adopt measures to promote morale, efficiency, integrity, responsiveness, progressiveness and courtesy in the civil service;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;
