RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE AMENDMENT TO THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE FEDERATION OF IRRIGATOR'S ASSOCIATIONS CENTRAL NEGROS – BAGO RIVER IRRIGATION SYSTEM (FIACN-BRIS), INC. RELATIVE TO THE EXTENSION OF THE USE OF AGRICULTURAL EQUIPMENT OF THE SAID ASSOCIATION FOR THEIR AGRICULTURAL PRODUCTION ACTIVITIES

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Amendment to the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Federation of Irrigator's Associations Central Negros – Bago River Irrigation System (FIACN-BRIS), Inc. relative to the extension of the use of agricultural equipment of the said association for their agricultural production activities;
