RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, THROUGH THE LORENZO D. ZAYCO DISTRICT HOSPITAL AND THE MUNICIPALITY OF ILOG RELATIVE TO THE REFERRAL OF PATIENTS FROM THE ILOG PRIMARY HEALTH CARE FACILITY FOR PHARMACEUTICAL SERVICES, CLINICAL LABORATORY SERVICES (INCLUDING CBC, URINALYSIS, LIPID PROFILE, HEPATITIS SCREENING, HIV TESTING, PAP SMEAR AND OTHER DIAGNOSTIC TESTS), DIAGNOSTIC AND IMAGING SERVICES (ECG, ULTRASOUND, CHEST X-RAYS), AMBULANCE SERVICES THROUGH A DOH-LICENSED UNIT COORDINATED VIA PROVINCIAL 911 AND ONE HOSPITAL COMMAND AND ADMINISTRATIVE SERVICES INCLUDING AUGMENTATION OF TRAINED ICD-10 CODERS AND MEDICAL RECORDS STAFF TO THE LORENZO D. ZAYCO DISTRICT HOSPITAL EFFECTIVE UPON SIGNING THEREOF AND SHALL CONTINUE FOR A PERIOD OF ONE YEAR UNLESS TERMINATED EARLIER BY EITHER PARTY.

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of Negros Occidental is the request of the Provincial Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental through the Lorenzo D. Zayco District Hospital and the Municipality of Ilog relative to the referral of patients from the Ilog Primary Health Care Facility for pharmaceutical

services, clinical laboratory services (including CBC, urinalysis, lipid profile, hepatitis screening, HIV testing, pap smear and other diagnostic tests), diagnostic and imaging services (ECG, ultrasound, chest x-rays), ambulance services through a DOH-licensed unit coordinated via Provincial 911 and One Hospital Command and administrative services including augmentation of trained ICD-10 coders and medical records staff to the Lorenzo D. Zayco District Hospital effective upon signing thereof and shall continue for a period of one year unless terminated earlier by either party;

WHEREAS, the Memorandum of Agreement constitutes a valid exercise of inter-local government cooperation, consistent with Sections 33 of the Local Government Code, which allows LGUs to enter into cooperative agreements to promote and deliver basic services;

WHEREAS, the said agreement is also aligned with the goals of the Universal Health Care Act (R.A. No.11223), particularly in ensuring integration of primary care networks with higher-level hospitals;

WHEREAS, the agreement clearly delineates the roles, obligations, and accountabilities of the parties, provides mechanism for implementation and compliance, and ensures service continuity for the benefit of patients;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Provincial Governor to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental through the Lorenzo D. Zayco District Hospital and the Municipality of Ilog relative to the referral of patients from the Ilog Primary Health Care Facility for pharmaceutical services, clinical laboratory services (including CBC, urinalysis, lipid profile, hepatitis screening, HIV testing, pap smear and other diagnostic tests), diagnostic and imaging services (ECG, ultrasound, chest x-rays), ambulance services through a DOH-licensed unit coordinated via Provincial 911 and One Hospital Command and administrative services including augmentation of trained ICD-10 coders and medical records staff to the Lorenzo D.
