***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF
THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY
AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CENTRAL
PHILIPPINE STATE UNIVERSITY (CPSU) RELATIVE TO THE IMPLEMENTATION
OF PROJECT TANOM (TANOM AKSYON, NEGROS OCCIDENTAL ON MISSION)***

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Central Philippine State University (CPSU) relative to the implementation of Project Tanom (Tanom Aksyon, Negros Occidental on Mission);

WHEREAS, the MOA outlines the respective commitments of each party in furtherance of environmental conservation, biodiversity enhancement, research development, and local agricultural sustainability;

WHEREAS, the Province of Negros Occidental (PGNO) shall extend policy direction, institutional and technical assistance, logistical support, and financial aid necessary for the implementation of Project TANOM and the establishment of the Botanical Garden and Conservation Complex;

WHEREAS, the Central Philippine State University (CPSU) commits to provide the project site consisting of six (6) hectares of university property, manpower, technical expertise, and funding support for project management;

WHEREAS, the agreement is legally sound and consistent with the mandates of both PGNO and CPSU and is well within the authority of the Provincial Government under Section 16 of the Local Government Code of 1991, which empowers local government units to promote ecological balance, scientific advancement, agricultural productivity, and the general welfare of their constituents ;

WHEREAS, the proposed cooperation aligns with statutory mandates, supports environmental and agricultural development, and strengthens research and conservation efforts within the province;

WHEREAS, the agreement shall take effect upon signing by both parties and shall remain valid for fifty (50) years and renewable for another fifty (50) years, unless earlier terminated by either party upon Ninety (90) days' written notice, or extended upon mutual agreement;

WHEREAS, in view of the foregoing, the SP Committee on Environment, finding the same to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Arthur Christopher D. Marañon and duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Central Philippine State University (CPSU) relative to the implementation of Project Tanom (Tanom Aksyon, Negros Occidental on Mission).
