RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, EUGENIO JOSE V. LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE MEMBER LGUs OF THE NORTHERN CORRIDOR, NAMELY SAN CARLOS CITY, CALATRAVA, TOBOSO, ESCALANTE CITY, SAGAY CITY, CADIZ CITY, MANAPLA, VICTORIAS CITY, EB MAGALONA AND SILAY CITY FOR THE WETLANDS CONSERVATION ALIANCE OF NORTHERN NEGROS (WeCANN)
