panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in accord with the provisions under Republic Act 7160 of the Local Government Code of 1991 mandating Local Government Units to formulate their local development plans/programs/projects/activities based on their respective thrusts/priorities;
