RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND VILLANUEVA CLINICAL LABORATORY RELATIVE TO THE REFERRAL OF PATIENTS FROM THE LORENZO D. ZAYCO DISTRICT HOSPITAL TO THE SAID CLINIC FOR DIAGNOSTIC AND LABORATORY SERVICES TO TAKE EFFECT FROM JANUARY 1, 2026 TO DECEMBER 31, 2026

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and South Health Clinical Lab relative to the referral of patients from the Lorenzo D. Zayco District Hospital to the said clinic for Diagnostic, Laboratory, CT Scan, Ultrasound services to take effect from January 1, 2026 to December 31, 2026;

WHEREAS, the subject agreement is consistent with the Universal Health Care Act, which promotes the establishment of coordinated health networks and partnerships with accredited private providers to expand access to diagnostic and ancillary services;

WHEREAS, the agreement shall be effective from January 1, 2026 to December 31, 2026 and shall remain valid for a period of one (1) year, unless terminated earlier by either party through thirty (30) days' prior notice;

WHEREAS, in view of the foregoing, the SP Committee on Health, finding the same to be in order, deemed it best to approve the same;
