**RESOLUTION APPROVING CITY ORDINANCE NO. 09-2025, OF THE CITY OF
CADIZ, NEGROS OCCIDENTAL MANDATING ADDITIONAL REQUIREMENTS FOR
ACCREDITATION AND/OR RENEWAL OF ACCREDITATION OF NON-
GOVERNMENT ORGANIZATIONS (NGOs) IN CADIZ CITY**

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 09-2025, of City of Cadiz, Negros Occidental, mandating additional requirements for accreditation and/or Renewal of Accreditation of Non-Government Organizations (NGOs) in Cadiz City was submitted for review by the City of Cadiz to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, the enactment of the subject ordinance finds legal basis under the Local Government Code of 1991 (RA No. 7160), particularly Sections 16 and 17, which empower local government units to enact measures that promote the general welfare of their constituents, including the regulation and oversight of organizations seeking to operate within the LGU's jurisdiction;

WHEREAS, the subject ordinance is consistent with the city government's mandate to ensure transparency, accountability, and compliance of NGOs with applicable rules and regulations, while safeguarding the interests of the community;

WHEREAS, the additional requirements do not unduly restrict the operation of NGOs but rather provide a structured process to verify their qualifications and alignment with local development objectives;

WHEREAS, in view of the foregoing, the SP Committee on Cooperatives recommends approval of the same;

NOW THEREFORE, on motion of Hon. Jeffrey T. Tubola, and duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 09-2025, of City of Cadiz, Negros Occidental, mandating additional requirements for accreditation and/or Renewal of Accreditation of Non-Government Organizations (NGOs) in Cadiz City.
