RESOLUTION APPROVING RESOLUTION NO. 2025-274 OF THE MUNICIPALITY OF MURCIA ADOPTING/APPROVING MDC RESOLUTION NO. 25-012, SERIES OF 2025, RESOLUTION RE-PROGRAMMING FUNDS FROM THE VARIOUS PROJECTS FUNDED FROM THE MDRRM SPECIAL TRUST FUND CY 2025 ENDORSING THE SAME TO THE SB AND TO INCLUDE/REVISED THE AIP CY 2025

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-274 of the Municipality of Murcia adopting/approving MDC Resolution No. 25-012, series of 2025, resolution re-programming funds from the various projects funded from the MDRRM Special Trust Fund CY 2025 endorsing the same to the SB and to include/revised the AIP CY 2025;
