**RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2025-206 OF THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL, FIXING THE HOURLY RENTAL FEE FOR THE BOOM TRUCK OWNED BY THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL AND PRESCRIBING THE GUIDELINES FOR ITS USE BY GOVERNMENT OFFICES, AGENCIES, PRIVATE INDIVIDUALS, OR ENTITIES**

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, Municipal Ordinance No. 2025-206 of the Municipality of Moises Padilla, Negros Occidental, entitled: "AN ORDINANCE FIXING THE HOURLY RENTAL FEE FOR THE BOOM TRUCK OWNED BY THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL AND PRESCRIBING THE GUIDELINES FOR ITS USE BY GOVERNMENT OFFICES, AGENCIES, PRIVATE INDIVIDUALS, OR ENTITIES" was submitted for review by the Municipality of Moises Padilla to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, the subject Ordinance is pursuant to Section 16 of the Local Government Code of 1991, particularly in ensuring the delivery of basic services, promoting public safety, and supporting local economic activities;

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Laurence Marxlen J. de la Cruz and unanimously seconded by all the members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to declare Municipal Ordinance No. 2025-206 of the Municipality of Moises Padilla, Negros Occidental, as valid enacted ordinance.
