**RESOLUTION APPROVING ORDINANCE NO. 07, SERIES OF 2025 OF THE  
MUNICIPALITY OF VALLADOLID PROHIBITING AND PENALIZING ILLEGAL  
GAMBLING WITH THE MUNICIPALITY OF VALLADOLID, NEGROS OCCIDENTAL,  
PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER  
PURPOSES**

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, City Ordinance No. 07, series of 2025 of the Municipality of Valladolid, Negros Occidental prohibiting and penalizing illegal gambling with the Municipality of Valladolid, Negros Occidental, providing penalties and violations thereof, and for other purposes was submitted for review by the Municipality of Valladolid to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, the subject ordinance is aligned with the provisions of the Local Government Code, specifically, under Section 16 which empowers local governments to promote general welfare, maintain peace and order, and improve public morals, as well as Section 446(a)(l)(v), which authorizes the Sangguniang Bayan to enact ordinances needed for effective governance.
