
RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 001, SERIES OF 2025 OF THE MUNICIPALITY OF PONTEVEDRA, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 OF THE SAID MUNICIPALITY IN THE AMOUNT OF SIX MILLION THREE HUNDRED THIRTY FOUR THOUSAND FOUR HUNDRED NINETEEN PESOS AND THIRTY FIVE CENTAVOS (P6,334,419.35)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 1 of the Municipality of Pontevedra, Negros Occidental with a total appropriation of P6,334,419.35, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 001, series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 001, series of 2025 of the Municipality of Pontevedra covering the 2025 General Fund Supplemental Budget No. 1 of the said municipality with a total appropriation of P6,334,419.35 and considered operative in its entirety subject to the posting requirement under Section 59 of LGC 1991 and subject to the condition that the utilization of the 20% Development Fund shall be disbursed in accordance with the general policies prescribed under JMC No. 1 of the DBM, DoF and DILG dated November 2, 2020 and shall proceed from itemized appropriations for specific development projects / activities, instead by lump sum, embodied in the Local Development Plan and/or public investment program formulated and prioritized by the Local Development Council and approved by the Sanggunian as provided under Section 454(d) of the IRR of RA 7160.

RESOLVED FURTHER, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
