**RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-208 OF THE MUNICIPALITY OF MOISES PADILLA AUTHORIZING THE MUNICIPAL VICE MAYOR TO AUGMENT THE AMOUNT OF P109,164.00 FROM BUDGETS OF PCL TRAVELING EXPENSES, OFFICE SUPPLIES AND TRAININGS AND SEMINARS TO THE BUDGET FOR TRAVELING EXPENSES – LOCAL, UNDER THE OFFICE OF THE SANGGUNIANG BAYAN**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2025-208 of the Municipality of Moises Padilla authorizing the Municipal Vice Mayor to augment the amount of P109,164.00 from budgets of PCL Traveling Expenses, office supplies and trainings and seminars to the budget for Traveling Expenses – Local, under the Office of the Sangguniang Bayan;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

**WHEREAS**, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Moises Padilla to enact pursuant to Section 336 of R.A. 7160, otherwise known as the Local Government Code of 1991 and Article 454 (b)(2) of its Implementing Rules and Regulations;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
