**RESOLUTION APPROVING CITY ORDINANCE NO. 25-18 OF THE CITY OF BAGO, NEGROS OCCIDENTAL, TRANSFERRING THE VARIOUS EXISTING SECTIONS/DIVISIONS AND CORRESPONDING PLANTILLA POSITIONS FROM THE OFFICE OF THE CITY MAYOR TO THE OFFICE OF THE CITY HEALTH OFFICER**

**WHEREAS**, thereby presented for appropriate action of the Sangguniang Panlalawigan of Negros Occidental is City Ordinance No. 25-18 of the City of Bago, Negros Occidental, entitled: "AN ORDINANCE TRANSFERRING THE FOLLOWING EXISTING SECTION/DIVISION AND PLANTILLA POSITIONS IN THE OFFICE OF THE CITY MAYOR, THIS CITY, TO THE HEREUNDER STATED OFFICE, IN VIEW OF ITS NEED AND PROVIDING FUNDS THEREFOR";
