***RESOLUTION DECLARING ORDINANCE NO. 25-23 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL, IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF REPUBLIC ACT NO. 7160 AND REPUBLIC ACT NO. 6758, AS A VALID ENACTED ORDINANCE***

***WHEREAS***, thereby presented to the Board for review and appropriate action is Ordinance No. 25-23 of the City of San Carlos, Negros Occidental, entitled: "AN ORDINANCE IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF REPUBLIC ACT NO. 7160 AND REPUBLIC ACT NO. 6758;
