RESOLUTION DECLARING ORDINANCE NO. 25-23 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL, IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF REPUBLIC ACT NO. 7160 AND REPUBLIC ACT NO. 6758, AS A VALID ENACTED ORDINANCE

WHEREAS, thereby presented to the Board for review and appropriate action is Ordinance No. 25-23 of the City of San Carlos, Negros Occidental, entitled: "AN ORDINANCE IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF REPUBLIC ACT NO. 7160 AND REPUBLIC ACT NO. 6758;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the said ordinance reveals that the same is consistent with the provisions as stated in Sections 76 and 458(a)(1)(viii) of Republic Act 7160 otherwise known as the Local Government Code of 1991;
