***RESOLUTION DECLARING ORDINANCE NO. 10, SERIES OF 2025 OF THE CITY OF SILAY, NEGROS OCCIDENTAL, AUTHORIZING THE CITY MAYOR AND CITY VICE MAYOR TO AUGMENT ANY ITEM IN THE APPROVED ANNUAL GENERAL FUND BUDGET OF THE CITY OF SILAY FOR CY 2026 FOR THEIR RESPECTIVE OFFICES FROM SAVINGS TO OTHER ITEMS WITHIN THE SAME EXPENSE CLASS OF THEIR RESPECTIVE APPROPRIATIONS, AS PROVIDED UNDER SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991, PROVIDED THAT THE IMPLEMENTATION OF THE FOREGOING ORDINANCE SHALL BE IN ACCORDANCE WITH ALL EXISTING NATIONAL AND LOCAL LAWS, AUDITING RULES AND ACCOUNTING PROCEDURES AS A VALID ENACTED ORDINANCE***

***WHEREAS***, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

PROCEDURES” was submitted for review by the City of Silay to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office and the Local Finance Committee, it is the recommendation of the said Offices that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Silay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, subject ordinance finds legal basis under Section 336 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same,

**NOW, THEREFORE**, on motion of Hon. Hope Marey B. Depasucat and unanimously seconded by all the members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to declare Ordinance No. 10, Series of 2025 of the City of Silay, Negros Occidental, as a valid enacted ordinance.
