3. Bago 3 Hydroelectric Power Project (34.8 MW) -Municipality of Murcia, Negros Occidental

WHEREAS, as the Province continues to advance the SecuRE Negros campaign, the Alsons Power Group remains committed in supporting the transition to renewable energy. We recognize that Negros Occidental continues to face energy insecurity brought about by recurring power outages and increasing electricity rates.
