RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDA OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CITIES OF BAGO, LA CARLOTA AND THE MUNICIPALITIES OF LA CASTELLANA, MOISES PADILLA, PONTEVEDRA, BINALBAGAN, HINIGARAN AND ISABELA FOR THE ALLOCATION OF PORTIONS OF THE DONATED FUNDS FROM THE OFFICE OF THE PRESIDENT TO THE SAID LGU'S TO PROVIDE FINANCIAL ASSISTANCE TO QUALIFIED BENEFICIARIES WHO ARE VICTIMS OF TYPHOON "TINO"

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memoranda of Agreement to be entered into by and between the Province of Negros Occidental and the Cities of Bago, La Carlota and the Municipalities of La Castellana, Moises Padilla, Pontevedra, Binalbagan, Hinigaran and Isabela for the allocation of portions of the donated funds from the Office of the President to the said LGU's to provide financial assistance to qualified beneficiaries who are victims of Typhoon "Tino";

This resolution shall take effect immediately upon approval.


