RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 449, SERIES OF 2025 OF THE MUNICIPALITY OF MURCIA, NEGROS OCCIDENTAL REVERTING THE TOTAL AMOUNT OF P8,600,000.00 ONLY FROM MOOE OF THE 2025 ANNUAL BUDGET TO SAVINGS

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 449, series of 2025 of the Municipality of Murcia, Negros Occidental reverting the total amount of P8,600,000.00 only from MOOE of the 2025 Annual Budget to savings;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Murcia to enact pursuant to the provisions of Article 454 (b)(1) of its Implementing Rules and Regulations of the 1991 Local Government Code;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
