RESOLUTION APPROVING RESOLUTION NO. 2025-106 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL, CONCURRING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 09, SERIES OF 2025, RE-PROGRAMMING THE AMOUNT OF EIGHT HUNDRED THIRTY THOUSAND PESOS (P830,000.00) FOR VARIOUS PROGRAMS AND PROJECTS FROM CY 2025 – 20% MUNICIPAL DEVELOPMENT FUND TO OTHER PRIORITY PROGRAMS AND PROJECTS OF THE SAID MUNICIPALITY

WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 2025-106 of the Municipality of San Enrique, Negros Occidental, concurring Municipal Development Council Resolution No. 09, Series of 2025, entitled: "Resolution Re-programming the Amount of Eight Hundred Thirty Thousand Pesos (P830,000.00) for Various Programs and Projects from CY 2025 – 20% Municipal Development Fund to Other Priority Programs and Projects on the Municipality of San Enrique, Negros Occidental;
