RESOLUTION APPROVING RESOLUTION NO. 2025-106 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL, CONCURRING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 09, SERIES OF 2025, REPROGRAMMING THE AMOUNT OF EIGHT HUNDRED THIRTY THOUSAND PESOS (P830,000.00) FOR VARIOUS PROGRAMS AND PROJECTS FROM CY 2025 – 20% MUNICIPAL DEVELOPMENT FUND TO OTHER PRIORITY PROGRAMS AND PROJECTS OF THE SAID MUNICIPALITY

WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 2025-106 of the Municipality of San Enrique, Negros Occidental, concurring Municipal Development Council Resolution No. 09, Series of 2025, entitled: “Resolution Reprogramming the Amount of Eight Hundred Thirty Thousand Pesos (P830,000.00) for Various Programs and Projects from CY 2025 – 20% Municipal Development Fund to Other Priority Programs and Projects on the Municipality of San Enrique, Negros Occidental;
