WHEREAS, thereby presented for review and appropriate action of Sangguniang Panlalawigan of Negros Occidental is Resolution No. 2025-397 of the City of Victorias, entitled: "RESOLUTION APPROVING THE 2026 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 OF VICTORIAS CITY";
