***RESOLUTION DISAPPROVING RESOLUTION NO. 221-2025 OF THE MUNICIPALITY OF VALLADOLID, NEGROS OCCIDENTAL, ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) FOR 20% DEVELOPMENT FUND FOR THE CY 2025 OF THE SAID MUNICIPALITY IN THE AMOUNT OF ELEVEN MILLION EIGHT HUNDRED SEVENTY THREE THOUSAND ONE HUNDRED FIFTEEN PESOS AND NINETY SIX CENTAVOS (P11,873,115.96)***

***WHEREAS***, thereby presented to the Board for review and appropriate action is Resolution No. 221-2025 of the Municipality of Valladolid, Negros Occidental, adopting the Supplemental Annual Investment Plan (AIP) for 20% Development Fund for the CY 2025 of the Municipality of Valladolid, Negros Occidental in the total amount of Eleven Million Eight Hundred Seventy Three Thousand One Hundred Fifteen Pesos and Ninety Six Centavos (P11,873,115.96);

***WHEREAS***, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

***WHEREAS***, a review of the said ordinance by the Provincial Planning and Development Office shows that the Municipality of Valladolid failed to submit/attached Municipal Development Council Meeting Resolution and the Supplemental Annual Investment Program (AIP);
