2. *The grant of the Service Recognition Incentive (SRI) to Government Employees for FY 2025 must be in accordance with the provisions of Budget Circular No. 2025-3 dated December 15, 2025 of the Department of Budget and Management;*

WHEREAS, in view of the foregoing, the SP Committee on Finance, finding the documents to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Nicholas M. Yulo, unanimously seconded by all members present;
