RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-04 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWENTY FOUR MILLION THREE HUNDRED FORTY THOUSAND PESOS (P24,340,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2025-04 of the Municipality of Calatrava, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 4 of the said municipality in the total amount of Twenty Four Million Three Hundred Forty Thousand Pesos (P24,340,000.00) that was submitted to the Sangguniang Panlalawigan for review on December 18, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

NOW, THEREFORE, on motion of Hon. Laurence Marxlen J. Dela Cruz and unanimously seconded by all members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-04 of the Municipality of Calatrava, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 4 of the said municipality in the total amount of Twenty Four Million Three Hundred Forty Thousand Pesos (P24,340,000.00) subject to the following conditions:

1. The grant of Gratuity Pay for Contract of Service (COS) and Job Order (JO) Workers in Government for FY 2025 shall be in accordance with the provisions of Budget Circular NO. 2025-4 dated December 16, 2025 of the Department of Budget and Management;
2. The grant of Collective Negotiation Agreement (CNA) Incentive for 2025 shall be subject to the guidelines of Budget Circular No. 2025-2, dated November 19, 2025 of the Department of Budget and Management;
3. The grant of Service Recognition Incentive (SRI) to Government employees for FY 2025 must be in accordance with the provisions of Budget Circular No. 2025-3 dated December 15, 2025 of the Department of Budget and Management;

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
