RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 25-05 OF THE CITY OF BAGO, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID CITY IN THE AMOUNT OF EIGHT HUNDRED EIGHTY NINE THOUSAND SEVEN HUNDRED FORTY THREE PESOS AND SEVENTY FOUR CENTAVOS (P889,743.74)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 5 of the City of Bago, Negros Occidental with a total appropriation of Eight Hundred Eighty Nine Thousand Seven Hundred Forty Three Pesos and Seventy Four Centavos (P889,743.74), enacted by the Sangguniang Panlungsod of the said city per Appropriation Ordinance No. 25-05;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety effective October 15, 2025, the Appropriation Ordinance No. 25-05 of the City of Bago, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code, and further subject to the condition and reminders that:

1. the utilization of 5% Local Disaster Risk Reduction and Management Fund shall be in accordance Republic Act No. 10121 and its Implementing Rules and Regulations, Commission on Audit Circular No. 2012-02 dated September 12, 2012 and National Disaster Risk Reduction and Management Council-Department of Budget and Management-Department of Interior and Local Government Joint Memorandum Circular No. 2013-1 dated March 25, 2013. Furthermore, the Local Disaster Risk Reduction and Management Plan of the city should be reviewed by the Office of the Civil Defense pursuant to Section 9(e) of Republic Act No. 10121.

RESOLVED FURTHER, that this Resolution does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government and compliance with the existing laws, rules and regulations shall be the responsibility of the city.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
