RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-03 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID CITY IN THE AMOUNT OF TWENTY FOUR MILLION NINETY THOUSAND PESOS (P24,090,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 3 of the City of Himamaylan, Negros Occidental with an appropriation of P24,090,000.00;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

NOW, THEREFORE, on motion of Hon. Hadji P. Trojillo, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-03 of the City of Himamaylan covering the 2025 General Fund Supplemental Budget No. 3 of the said city with an appropriation of P24,090,000.00 and considered operative in its entirety effective November 21, 2025 subject to the posting requirement under Section 59 of LGC 1991.

RESOLVED FURTHER, that the LGU is reminded that the Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which provides that, “every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor, or city of municipal mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every pages thereof...xxx”.:

RESOLVED FINALLY, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.
