RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-05 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY IN THE AMOUNT OF TWENTY ONE MILLION SIX HUNDRED FIFTY THOUSAND (P21,650,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 General Fund Supplemental Budget No. 4 of the City of Himamaylan, Negros Occidental, amounting to Twenty One Million Six Hundred Fifty Thousand (P21,650,000.00), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2025-05;

WHEREAS, the above-mentioned budget shows substantial compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Hadji P. Trojillo, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective December 17, 2025, the Appropriation Ordinance No. 2025-05 of the City of Himamaylan, Negros Occidental covering the FY 2025

General Fund Supplemental Budget No. 4 of the said city amounting to Twenty One Million Six Hundred Fifty Thousand (₱21,650,000.00), subject to the posting requirements under Section 59 of the Local Government Code of 1991, and the following conditions and reminders:

1. The grant of Collective Negotiation Agreement (CAN) Incentive shall be in accordance with the provisions of Budget Circular No. 2025-2 dated November 19, 2025 of the Department of Budget and Management;
2. The grant of Service Recognition Incentive (SRI) shall be in accordance with the provisions of Budget Circular No. 2025-3, dated December 15, 2025 of the Department of Budget and Management;
3. The local government unit must adopt the correct format of Local Budget Preparation Form No. 9 (Statement of Supplemental Appropriation) as illustrated under page 71 of the Budget Operations Manual for Local Government Units -2023 Edition, and indicate the proper AIP reference codes under column three (3) thereof. The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP;
4. The city is reminded that the Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54 (a) of the Local Government Code, which provides that, "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the LGE concerns approves the same, he shall affix his signature on each and every page thereof"...xxx.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
