RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 04, SERIES OF 2025 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 4 of the Municipality of San Enrique, Negros Occidental with an appropriation of P1,000,000.00;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

NOW, THEREFORE, on motion of Hon. Nicholas M. Yulo, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 04, series of 2025 of the Municipality of San Enrique covering the 2025 General Fund Supplemental Budget No. 4 of the said municipality with an appropriation of P1,000,000.00 and considered operative in its entirety effective December 9, 2025 subject to the posting requirement under Section 59 of LGC 1991.
