RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 07, SERIES OF 2025 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION SIX HUNDRED SEVENTY THOUSAND PESOS (P2,670,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 6 of the Municipality of San Enrique, Negros Occidental with an appropriation of P2,670,000.00;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A.
