**RESOLUTION APPROVING RESOLUTION NO. 25-445 OF THE CITY OF SILAY, NEGROS OCCIDENTAL, ADOPTING AND APPROVING THE SILAY CITY DEVELOPMENT COUNCIL RESOLUTION NO. 11, SERIES OF 2025, ENDORSING THE LIST OF THE PROJECTS, PROGRAMS AND/OR ACTIVITIES (PPAs) FROM CIVIL SOCIETY ORGANIZATION (CSO) AMOUNTING TO FORTY SIX MILLION THREE HUNDRED THOUSAND PESOS (P46,300,000.00) FOR THE INCLUSION IN THE ANNUAL INVESTMENT PLAN (AIP) 2026**
