AN ORDINANCE CREATING CASUAL POSITIONS UNDER THE NEGROS OCCIDENTAL TOURISM DIVISION (NOTD) – OFFICE OF THE GOVERNOR OF THE PROVINCE OF NEGROS OCCIDENTAL THEREBY ADOPTING THE REVISED PERSONNEL SCHEDULE OF CASUAL EMPLOYEES AND AUTHORIZING THE GOVERNOR TO AUGMENT THE PERSONNEL SERVICES (PS) COST FROM THE PS SAVINGS OF THE SAID OFFICE

BE IT ENACTED, by the Sangguniang Panlalawigan of Negros Occidental in its Regular Session duly assembled that:


